AGREEMENT

THIS AGREEMENT made by and between the undersigned CUSTOMER and R Heroes USA, LLC. A Manufacturer Limited Liability Corporation of P.O. Box 485, City of San Dimas, State of California, referred to as R Heroes USA.

CUSTOMER shall be in default of this Agreement if the CUSTOMER fails to pay, in full, the cost of services rendered under this Agreement within 30 days of the invoice date. If the CUSTOMER is in default of this Agreement, any and all unpaid portions of fees owed shall bear interest at the maximum rate allowed by law, compounded monthly, until collected from the date of invoicing.

In the event the CUSTOMER fails and/or refuses to make payment for services rendered under this Agreement or is in default of this Agreement, the CUSTOMER shall be responsible for all **ACTUAL** costs, attorney fees and interest incurred by R HEROES USA, LLC in the collection of the debt accumulated under this Agreement. Additionally, a fee of 20% of the bill will be assessed upon default.

CUSTOMER hereby consents and agrees that if the CUSTOMER is in default of the payments required herein, R HEROES USA, LLC may file a legal claim in Los Angeles County, California, rather than the County in which the CUSTOMER is located, and further that proper venue in all disputes between the parties hereto shall be in Los Angeles County, California. This Agreement will be governed by the laws of the State of California. This Agreement constitutes the entire agreement by the parties and supersedes any written or oral agreement of the parties prior to the date hereof. Amendments to this Agreement may only be made in writing and signed by the parties
